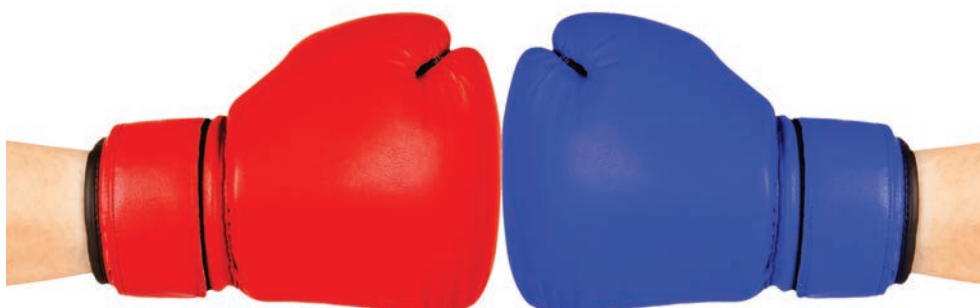

LETTER FROM THE FOUNDERS

In 2001 we established the Long Island Community Chest to raise money to help individuals and families in need across Long Island. In 2003 we created the Long Island Fight for Charity, which quickly became one of Long Island's most exciting and anticipated annual events. During the first 10 years, over \$850,000 was distributed to a diverse list of Long Island charities, including Long Island Community Chest. More than 180 volunteer boxers have met each other in the ring as opponents. The boxers have devoted over 8,000 hours in training to prepare for their bouts. Since our inception, more than 10,000 fans have attended Fight for Charity events.

We aim to break all fund-raising and attendance records in 2014. An event of this nature engages the resources of many people, and we wish to acknowledge their hard work and dedication. We raise our glasses and toast those who help make this event a success: from the Official Training Centers (Body Shots Boxing, Saint James, NY; Fitness through Boxing, East Northport, NY; Glen Cove Boxing Club, Glen Cove, NY) to the restaurants that feed the fans, the chairs and members of the committees and the volunteers who make the night happen, each person plays a key role in bringing this "Main Event" to life.

And let us not forget the Boxers, who take time out of their day to raise funds for good causes and spend hours in the gym at night and on weekends training for months so they can be ready to entertain more than a thousand screaming fans gathered around the ring to watch their matches.

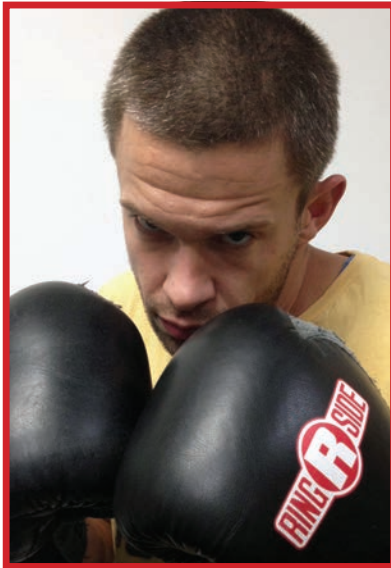

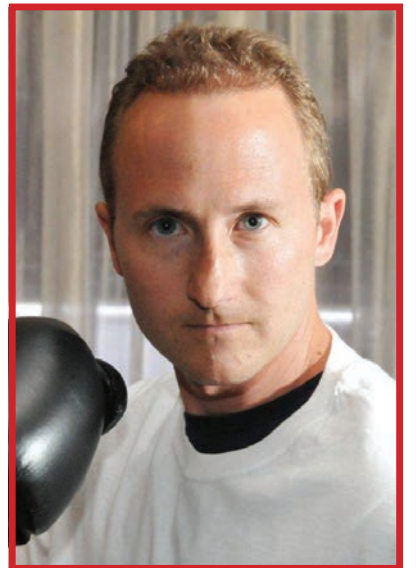
Jamie “Superfly” Stuart

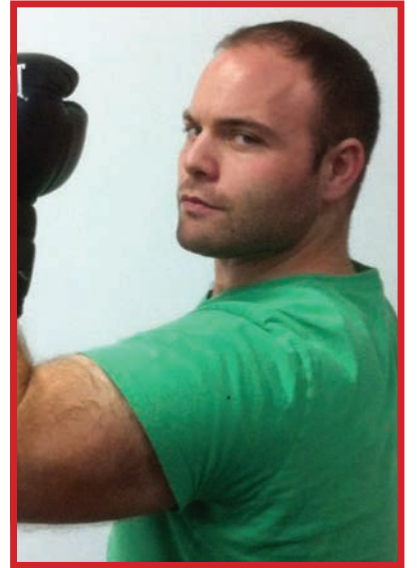

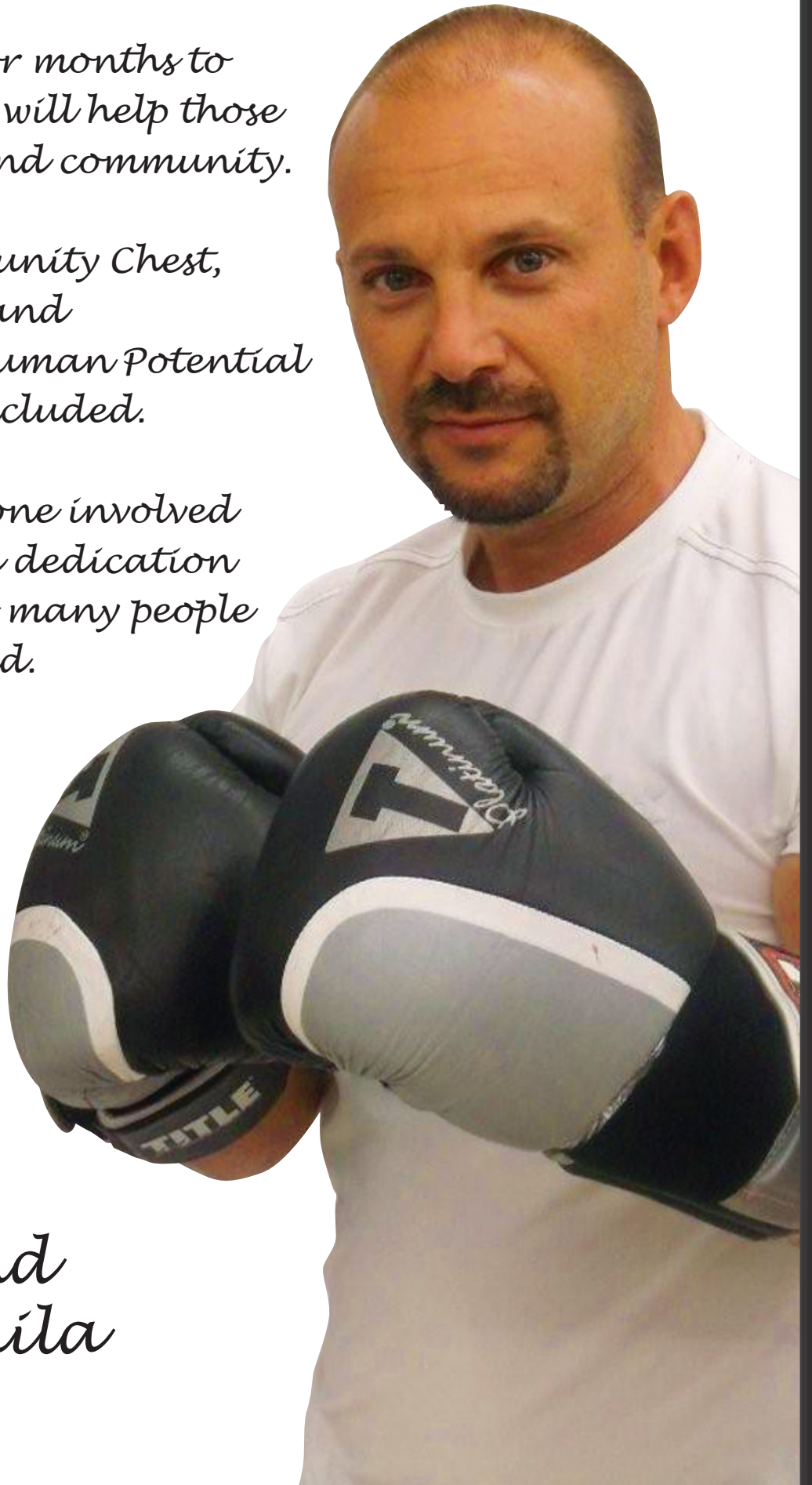
